**Eligibility:**

**1. Are current/former Community Grant Program grantees eligible to apply?**

The Community Grant Program 2023 announcement indicates, “Programs that were successful in their first year will be considered and are encouraged to reapply.” An organization may apply for the District Attorney’s Community Grant Program if they meet the 2023 eligibility criteria, and the program is in alignment with one of the four focus areas.

**2. What is the anticipated effective date/term for the 2023 Community Grant Program, and will this affect 2021 Community Grant Program grantees with program extensions that run past 06/01/2023?**

As indicated on the announcement webpage, the 2023 RFA has an anticipated timeframe outlined in the image below. The Community Grant Program anticipates grants will have 06/01/2023 effective dates. We will consider, and encourage, programs that were successful in their first year to reapply. If awarded, current grantees with program extensions past 06/01/2023 will work with the Community Grant Program on an individual basis.

**3. Are current/former K -12 Youth Services Community Grant Program grantees eligible to apply?**

San Diego County’s [K -12 Youth Services Community Grant Program](#) is distinct from the District Attorney’s Community Grant Program. An organization may apply for the District Attorney’s 2023 Community Grant Program if they meet the eligibility criteria, and the program is in alignment with one of the four focus areas.

**4. If an organization has multiple branches/locations, are they able to submit multiple applications?**

Organizations may submit multiple applications for programs throughout San Diego County.

**5. Are Title I Schools eligible to apply?**

Yes. Organizations with a Business License or a Non-Profit Organization are eligible.

**Programmatic:**

**6. Is a program required to satisfy all four focus areas?**

No – Applicants must select one of the four focus areas that best represents the proposed program/service.

**7. Can a youth soccer program that aims to keep kids safe and out of gangs be considered?**

All innovative ideas will be considered. The grant program is intended to fund innovative ideas in the four focus areas identified.

**8. Would programs in industrial areas be considered?**

There are no restrictions on service areas if they are within San Diego County.

**9. Would previously funded programs be considered for continuation?**

The Community Grant Program 2023 announcement indicates, “Programs that were successful in their first year will be considered and are encouraged to reapply.” An organization may apply for the District Attorney’s Community Grant Program if they meet the 2023 eligibility criteria, and the program is in alignment with one of the four focus areas. **Awards/Funding:**

**10. How many grants do you estimate will be awarded?**

The Community Grant Program anticipates granting 50 awards.

**11. If a grant is awarded to an existing program can some of the money be used for expenses incurred by the program before the grant? Some non-profits are facing deficits, but still carrying out the good work.**

Grant funds are not intended to supplant or replace existing funding.

**12. Will the Community Grant Program offer annual funding allocations?**

The grant program is intended to provide non-sustaining, seed funding towards new and innovative projects. Grant recipients are encouraged to have a sustainability plan to seek primary ongoing funding from other funding sources. If funding is available, programs are required to reapply once the grant term has ended.
