SYNOPSIS:

On 01/25/10 at 2200 hours, Jacob Daniels called 911 to report that he had been stabbed by a neighbor, Donna Jones. Officer J. Kilter received the call and responded to 130 16th Street in Sunny Dale. He encountered the victim, a male adult who was yelling loudly in the middle of the street. The victim, who was later identified as Jacob Daniels, appeared to be bleeding from multiple knife wounds. Daniels reported that he had been stabbed by his neighbor, Donna Jones who was contacted at her apartment and arrested for assault with a deadly weapon. Jones stated that Daniels attempted to rape her and she stabbed him to prevent the assault.

INVESTIGATION:

On 01/25/10, I was called to Headquarters to assist Officer J. Kilter #56 with the arrest and investigation of Donna Jones for assault with a deadly weapon.

Officer Kilter informed me that he received a dispatch call directing him to an apartment complex on 16th Street in sunny Dale. When he arrived he saw a large male adult screaming in the middle of the road, yelling, "that fucking bitch, that fucking bitch, that fucking bitch." He noticed that the male appeared to be bleeding and upon closer inspection Kilter saw that the individual had been stabbed. The individual was identified as Jacob Daniels. Kilter directed Daniels to the curb and called paramedics who arrived immediately. While waiting for paramedics, Daniels made a brief statement. Kilter detected the smell of alcohol as he waited with Daniels.

VICTIM'S STATEMENT TO KILTER:

I was in my apartment, listening to music and having some beers, with the door open, when I heard a knock on the screen. I noticed my next door neighbor, Donna Jones, was standing at the door with a big crazy smile on her face. I got up, opened the screen, and asked her what was going on. She pulled a giant knife out of her pants and started stabbing me over and over and over. I tried to get the knife away from her, so I grabbed her by the wrist and finally she took off running towards her place. You can't miss the crazy bitch, she has a red work out outfit on and long black hair in a braid. She took the knife, it's got to be in her apartment. She has two little kids in there too.

INVESTIGATION CONTINUED:

After the medics arrived, Kilter went into the apartment complex and contacted the manager, who showed him to Donna Jones apartment. Kilter knocked on eth door and got no answer, but noticed the door was open and the screen unlocked. Kilter opened the screen, reached over the threshold and pushed the door open so he could see inside. Kilter immediately noticed a large kitchen knife on the ground which appeared to be covered in blood. He could hear a female crying inside the apartment. Kilter went inside and found Donna Jones in her bedroom watching a loud television program where one of the female characters was crying. Jones started screaming and crying as soon as Kilter entered the room. Kilter noticed an operational landline and a cell phone that rang while he was in the bedroom. The bedroom was neat and orderly. No children were inside the home.

Kilter told Jones to stand and he searched her for weapons. Jones had dried blood on her arms and legs. Kilter asked Jones what happened and she said he tried to rape me and stabbed him. I want a lawyer. A cover officer transported Jones outside and sat her in the back of a police car.

As Kilter was leaving the complex he noticed that Daniel's apartment door was open. He went to shut the door and as he neared the apartment, he heard a radio coming from inside and noticed several empty beer cans on the dining room table. There was a trail of blood on the ground leading from the door of the apartment out to the street where he had contacted Daniels.

Kilter arrested Jones and took her to the police station. She was booked into custody and the following day I contacted Jones at the Women's Jail. I told Jones that she did not have to talk to me but that I was there to get her side of the story. Jones agreed to talk to me so I read her rights pursuant to Miranda. Jones said she understood and waived her rights.

SUSPECT'S STATEMENT:

I invited the victim over for dinner to convince him to join my gym and take advantage of a training special I was offering. Jacob agreed and came over to my house at 2000 hours. My kids were at their dad's house. I cooked a good meal and we ate together at the table. After dinner I started talking about the training special. Jacob became upset and started cursing at me saying, "You fucking bitch, you lured me over here to sell me a gym membership. Well you're gonna see how strong I am." Then he started to get up from the table and grabbed my wrist. I picked up the carving knife that was lying next to the chicken I had cooked and started to stab him. I knew he was going to rape me and he is so much bigger than me, I had to use the knife.

CHARGES:

Based on my investigation and the above listed information, I request the District Attorney review this case and issue the above listed charges.
