The application of Plaintiff, the People of the State of California, for a Permanent Injunction made herewith came on regularly for hearing by this Court on April 10, 2003. Plaintiff appeared by counsel Susan K. Mazza, Deputy District Attorney, and Terri A. Perez, Deputy District Attorney. It appearing that defendants, THE LOGAN HEIGHTS RED STEPS gang, an unincorporated association, and the thirty-six (36) defendants, PEDRO ANAYA; VICENTE ARROYO, a.k.a. "Chite"/ "Pocho"; ADAN BARAJAS, a.k.a., "Gordo"; ISRAEL BARAJAS; ERNESTO BERNAL, a.k.a. "Ernie"/ "Flannery"; MIGUEL CASTANEDA, a.k.a. "Grumpy"/ "Mike"/ "Scrappy"; JOSE JESUS DELGADO, a.k.a. "Chuey"; AMADO GARCIA, a.k.a. "Drowsy"/ "Morro"/ "Pato"; RICARDO GOMEZ, a.k.a. "Ricky"; CHRISTIAN DAVID GONZALEZ, a.k.a. "Cris"/ "Trusty"; MANUEL HERMOSILLO; RAFAEL VENEGAS HERMOSILLO, a.k.a. 12 ZARCO, a.k.a. "Coco", having been regularly served with process, having failed to appear and
13 answer the plaintiff's complaint filed on October 24, 2002, and the defaults of said defendants
14 having been duly entered and evidence having been introduced in open session of this Court or
15 having been considered by the Court:

16 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that the Permanent Gang
17 Injunction shall be and hereby is granted and that plaintiff recover no monetary sum from the
18 defendants.

19 **PERMANENT GANG INJUNCTION**

20 After due consideration of all papers filed in this action, including the moving papers and
21 evidence submitted in support of plaintiff's motion for preliminary injunction, the deemed
22 admissions of the defaulting defendants and the authorities presented by counsel, this Court makes
23 the following finding of facts by clear and convincing evidence:

24 (1) LOGAN HEIGHTS RED STEPS is a criminal street gang as defined in Penal Code
25 §186.22, having as one of its primary activities the commission of acts constituting a public
26 nuisance; (2) the conduct of defendant LOGAN HEIGHTS RED STEPS and its members constitutes
27 a public nuisance in the Safety Zones; (3) each of the following named defendants: PEDRO
28 ANAYA; VICENTE ARROYO, a.k.a. "Chite"/ "Pocho"; ADAN BARAJAS, a.k.a. "Gordo";
ISRAEL BARAJAS; ERNESTO BERNAL, a.k.a. "Ernie"/ "Flannery"; MIGUEL CASTANEDA,

1 a.k.a. "Grumpy"/ "Mike"/ "Scrappy"; JOSE JESUS DELGADO, a.k.a. "Chuey";-AMADO
2 GARCIA, a.k.a. "Drowsy"/ "Morro"/ "Pato"; RICARDO GOMEZ, a.k.a. "Ricky"; CHRISTIAN
3 DAVID GONZALEZ, a.k.a. "Cris"/ "Trusty"; MANUEL HERMOSILLO; RAFAEL VENEGAS

12 SANDOVAL; IVAN SOLIS, a.k.a. "Lil' Ivan"; EUCEBIO DUARTE TORRES, a.k.a.
13 "Junior"/"Lonely"; JUAN CARLOS TORRES, "Lil' Spanky"/ "Lil' Spook"; DANIEL TRINIDAD,
14 a.k.a. "Danny Boy"; ALFREDO UGALDE, a.k.a. "Moco"/ "Silent"/ "Serio"; CARLOS IVAN
15 VALADEZ; HECTOR VILLEGAS, a.k.a. "Lepo"/ "Silly"; and JOAQUIN ZARCO, a.k.a. "Coco"
16 is a member of the LOGAN HEIGHTS RED STEPS street gang whose membership is more than
17 passive, inactive or purely technical, and shall be referred to collectively at times hereafter as
18 "LOGAN HEIGHTS RED STEPS Gang Member"; (4) each named LOGAN HEIGHTS RED
19 STEPS Gang Member has been observed in the Safety Zones, and (5) each named LOGAN
20 HEIGHTS RED STEPS Gang Member is responsible in some manner for the nuisance complained
21 of by the plaintiff.

22 **IT IS ORDERED, ADJUDGED AND DECREED** that defendants: PEDRO ANAYA;
23 VICENTE ARROYO, a.k.a. "Chite"/ "Pocho"; ADAN BARAJAS, a.k.a. "Gordo"; ISRAEL
24 BARAJAS; ERNESTO BERNAL, a.k.a. "Ernie"/ "Flannery"; MIGUEL CASTANEDA, a.k.a.
25 "Grumpy"/ "Mike"/ "Scrappy"; JOSE JESUS DELGADO, a.k.a. "Chuey"; AMADO GARCIA,
26 a.k.a. "Drowsy"/ "Morro"/ "Pato"; RICARDO GOMEZ, a.k.a. "Ricky"; CHRISTIAN DAVID
27 GONZALEZ, a.k.a. "Cris"/ "Trusty"; MANUEL HERMOSILLO; RAFAEL VENEGAS
28 HERMOSILLO, a.k.a. "Rafa"; JOHN EDWARD JIMENEZ, a.k.a. "Skooby"; ROBERT JUAREZ,

10 the LOGAN HEIGHTS RED STEPS GANG, its members, agents, servants, and employees, and all
11 persons acting under, in concert with, or for any of them, are hereby enjoined and restrained from
12 engaging in or performing directly, or indirectly, any of the following activity in the Safety Zones.
13 The "LOGAN SAFETY ZONES" include "LOGAN SAFETY ZONE ONE" and "LOGAN
14 SAFETY ZONE TWO." "LOGAN SAFETY ZONE ONE" is as follows: The area bounded by the
15 1200 block of Imperial Avenue to Interstate 15 to the North; Interstate 15 from Imperial Ave.,
16 continuing south to Wabash Blvd., and connecting with 32nd St. south to Harbor Dr. to the East.;
17 1200 Harbor Dr. to 32nd St. to the South (also to include Crosby St./Cesar Chavez Way, south of
18 Harbor Dr. and Crosby St. park and the piers); and 12th Ave. from Imperial Ave. to the trolley tracks,
19 continuing south along the trolley tracks to Harbor Dr. to the West. "LOGAN SAFETY ZONE
20 TWO" is as follows: The area bounded by Market St. to the North; 54th St. south from Market St. to
21 Santa Margarita to the East; Santa Margarita from 54th St., connecting with Churchward west to
22 Imperial Ave. to the South; 47th St. from Imperial Ave. north to Market St. to the West. All streets
23 included in the LOGAN SAFETY ZONES include both sides of the streets, as well as any structures,
24 residences, businesses located thereon. Any alleys located behind such structures are also included
25 within the LOGAN SAFETY ZONES. (See Exhibit 1, attached hereto.)

26 a. **No Association:** Standing, sitting, walking, driving, bicycling, gathering or
27 appearing anywhere in public view with any other defendant herein, or with any other known
28 LOGAN HEIGHT RED STEPS, LOGAN TREINTA, LOGAN TRECE, OR ALS (ANOTHER
LOGAN SOLDIER) gang members. However, any of the named defendants who are brothers, may

1 appear together in public if they are with one of their parents;

2 b. **Stay Away From Drugs:** Using illegal drugs in public; being under the influence of
3 drugs in public;

4 c. **No Drug Possession or Sales:** (1) Participating in the possession and/or sale of
5 narcotics/drugs, including but not limited to heroin, methamphetamine, cocaine, marijuana; (2)
6 Possession of related drug paraphernalia, including but not limited to, rolling papers or pipes used
7 for illegal drug use;

8 d. **Stay Away From Alcohol:** (1) Drinking or possession alcoholic beverages; (2) Being
9 under the influence of alcohol; (3) Knowingly remaining in the presence of anyone possessing an
10 open container of an alcoholic beverage; (4) Knowingly remaining in the presence of an open
11 container of an alcoholic beverage;

12 e. **No Guns or Dangerous Weapons:** (1) Possessing any weapons: firearms, including
13 BB guns, pellet guns and replica guns, ammunition, knives, rocks, bottles, sharpened screwdrivers,
14 pipes, sticks, clubs, tire irons, or any other instrument prohibited by Penal Code section 12020; (2)
15 No possession of baseball bats, golf clubs, or tire irons without a legitimate purpose; (3) Knowingly
16 remaining in the presence of anyone who is in possession of such dangerous weapons; (4)
17 Knowingly remaining in the presence of such dangerous weapons;

18 f. **No Fighting:** Engaging in fighting in public streets, alleys, and/or public and private
19 property;

20 g. **No Graffiti/Vandalism Tools:** Possessing marker pens, spray paint cans, nails, razor
21 blades, or other sharp objects capable of defacing private or public property;

22 h. **No Graffiti/Vandalism:** Spray painting, marking with marker pens, scratching,
23 applying stickers or otherwise applying graffiti on any public or private property, including, but not
24 limited to the street, alley, residences, block walls, vehicles and/or any other real or personal
25 property;

26 i. **No Trespassing:** Being present on any property not open to the general public,
27 except with (1) the prior written consent of the owner, owner's agent, or the person in lawful
28 possession of the property or (2) in the presence of and with the voluntary consent of the owner,

1 owner's agent, or the person in lawful possession of the property;

2 j. **No Blocking Free Passage:** Blocking the free passage of any person or vehicle on
3 any street, walkway, sidewalk, driveway, alleyway, or other area of public passage;

4 k. **No Shooting of Guns:** Discharging any firearm, including BB guns;

5 l. **No Intimidation:** In any manner confronting, intimidating, annoying, harassing,
6 threatening, challenging, provoking, assaulting and/or battering any residents or patrons or visitors to
7 the LOGAN SAFETY ZONES, or any other persons who are known to have complained about gang
8 activities;

9 m. **No Contraband in Cars:** Driving or possessing a vehicle found to have any
10 contraband, drugs, or illegal or deadly weapons;

11 n. **No Burglary Tools:** Possessing burglar tools with no legitimate purpose, including
12 rocks, slim jims, spark plugs, or any part of the spark plug, including the porcelain casing, or other
13 devices capable of being used to break into locked vehicles;

14 o. **No Acting as Lookouts:** Signaling to, whistling, or acting as a lookout for other
15 persons to warn of the approach of police officers;

16 p. **No Littering:** Littering in any public place or place open to public view;

17 q. **No Urinating in Public:** Urinating on any public or private property open to public
18 view;

19 r. **No Gang Hand Signs:** Using physical gestures, or symbols, commonly known as
20 hand signs or engaging in other forms of communication which describe or refer to the gang known
21 as the LOGAN HEIGHTS RED STEPS, including, but not limited to: forming the letter "L" by
22 extending the index finger upward and extending the thumb to the side; forming the letter "H" by
23 extending the index and middle fingers to the sign, while the remaining fingers are closed in a fist,
24 which is also the letter "H" in sign language; forming the letter "R" by extending the index finger
25 and middle fingers upward and crossing them, while the other fingers remain in a fist, which is also
26 the letter "R" in sign language; forming the letter "S" by making a fist, with the index finger slightly
27 crooked above the rest of the fingers, which is the letter "S" in sign language.

1 s. **No Gang Clothes:** Wearing clothing or accessories, including necklaces or belt
2 buckles, which bear the name, initials, letters, numbers or other symbols of the gang known as the
3 LOGAN HEIGHTS RED STEPS, including, but not limited to: "LHRS"; "LRS"; "L"; "H"; "R";
4 "S"; "LOGAN"; "LOGAN HEIGHTS RED STEPS"; "LOGAN RED STEPS"; "RED STEPS"; "12
5 08"; "12"; "8"; "18 19"; "18"; "19"; "13";

6 t. **No Loud Noise:** No making or causing loud noise of any kind, including, but not
7 limited to, yelling and loud music at any time of the day or night, in violation of San Diego
8 Municipal Code sections 59.5.0101, 59.5.0102, 59.5.0501, 59.5.0601;

9 u. **Juvenile Curfew:** If under the age of eighteen (18), being in a public place between
10 the hours of 10:00 p.m. on any day, and 6:00 a.m., of the following day, unless (1) accompanied by a
11 parent or legal guardian, or by a spouse eighteen (18) years of age or older, or (2) performing an
12 errand directed by a parent or legal guardian, or by a spouse eighteen (18) years of age or older, or
13 (3) returning directly home from a public meeting, or a place of public
14 entertainment, such as a movie, play, sporting event, dance or school activity, or (4) actively
15 engaged in some business, trade, professionalism, or occupation which requires such presence;

16 v. For such other and further relief that the court may deem proper.



San Diego Trolley Safety Zones

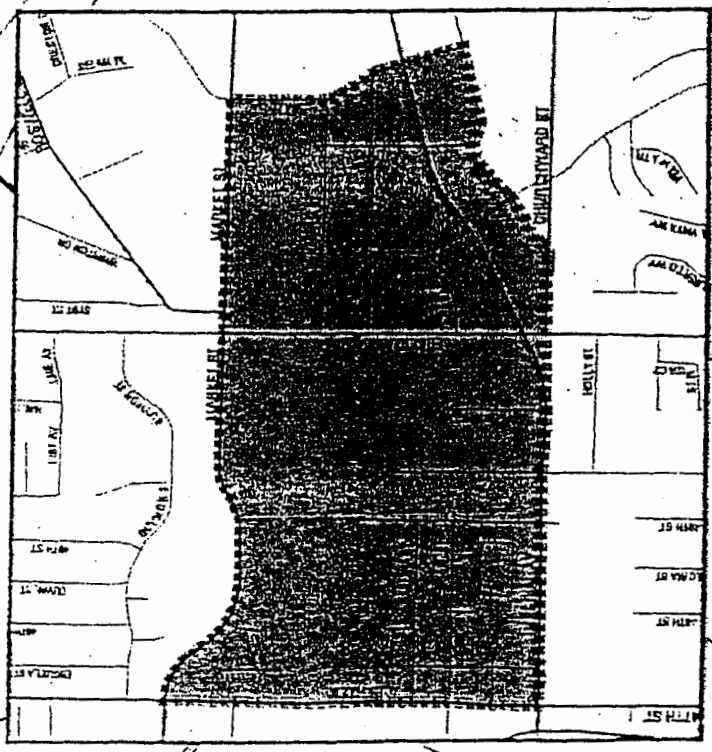
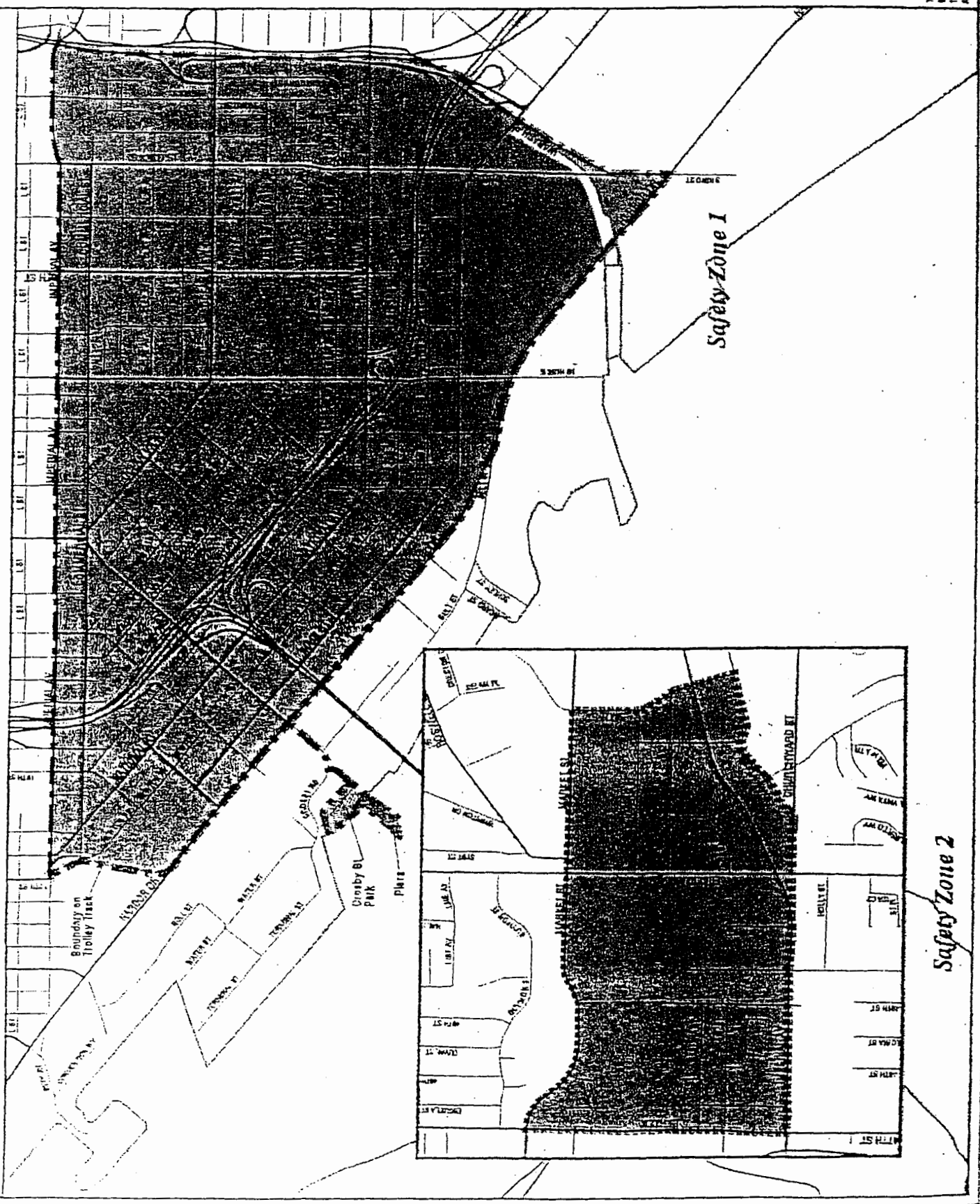
-  Safety Zone 1 Boundary
