13 PERMANENT GANG INJUNCTION

14 After due consideration of all papers filed in this action, including the moving papers and
15 evidence submitted in support of plaintiff's Ex Parte Application For Order To Show Cause Re:
16 Preliminary Injunction, the deemed admissions of the defaulting defendants and the authorities
17 presented by counsel, this Court makes the following finding of facts by clear and convincing
18 evidence:

20 Penal Code §186.22, having as one of its primary activities the commission of acts constituting a

17 hereafter as "OLD TOWN NATIONAL CITY GANG member"; (4) each named OLD TOWN
18 NATIONAL CITY GANG member has been observed in the Safety Zones, and (5) each named
19 OLD TOWN NATIONAL CITY GANG member is responsible in some manner for the
20 nuisance complained of by the plaintiff.

19 The area bounded by: The 00-800 blocks of Division Street, continuing north to the 00-400
20 blocks of N. Highland Avenue, continuing east to the 1100-1500 blocks of Scott Drive,
21 continuing north to the 00-399 blocks of N. Palm Avenue, continuing east to the 1600-1722
22 blocks of Alpha Street, continuing south to 341-300 blocks of N. "R" Avenue, continuing east to
23 the 1800-2400 blocks of Beta Street (Northern Boundary); the 100-00 blocks of N. Euclid
24 Avenue, continuing south from the 00-3200 blocks of Euclid Avenue (Eastern Boundary); the
25 00-1499 blocks of E. 30th Street, continuing east to the 1500-1999 blocks of Sweetwater Road,
26 and to also include the 0-224 blocks of W. 33rd Street (Southern Boundary); the west side of the
27 Interstate-5 Freeway, to also include the 1200-2299 blocks of McKinley Avenue and the 1200-
28 2499 blocks of Cleveland Avenue (Western Boundary); also including the area bounded by the
29 Pepper Park, 3200 Goesno Place; and extending 100 yards to the outside of each of the

1 boundary streets listed herein. SAFETY ZONE TWO: The area bounded by the Westfield
2 Shopping Town – Plaza Bonita, 2980, 3000-3999 blocks of Plaza Bonita Road, and extending
3 100 yards to the outside of any boundary streets listed herein. The SAFETY ZONES include
4 both sides of the streets listed above, as well as any alley, blocks, driveways, parking lots, and
5 businesses located thereon. (See Exhibit A, lodged herewith)

6 a. **No Association With Known Gang Member:** Standing, sitting, walking,
7 driving, gathering or appearing, anywhere in public view or any place accessible to the public,
8 with any named Defendant herein or any known member of the OLD TOWN NATIONAL
9 CITY GANG, also known as OTNC criminal street gang;

10 b. **No Intimidation:** Confronting, intimidating, annoying, harassing, threatening,
11 challenging, provoking, assaulting, or battering any person known to be a witness to or victim of
12 crime, or any person known to have complained about the gang activities of the OLD TOWN
13 NATIONAL CITY GANG also known as OTNC criminal street gang;

14 c. **Stay Away From Drugs In Public:** (1) Participating in the selling, possessing or
15 using of any controlled substance, or illegal drug, including, but not limited to: phencyclidine
16 (PCP), heroin, cocaine, cocaine base, methamphetamine, ecstasy and marijuana; (2) possession
17 of related drug paraphernalia, including, but not limited to, rolling papers, pipes, or other
18 devices used for injecting, smoking or ingesting illegal drugs; (3) knowingly remaining in the
19 presence or anyone selling, possessing, or using any controlled substance or illegal drug; or (4)
20 being under the influence of a controlled substance, or illegal drug;

21 d. **Stay Away From Alcohol In Public:** Anywhere in public view or anyplace
22 accessible to the public, (1) drinking or possessing an open container of an alcoholic beverage,
23 (2) being under the influence of alcohol; (3) knowingly remaining in the presence of anyone
24 possessing an open container of an alcoholic beverage in public; (4) knowingly remaining in the
25 presence of an open container of an alcoholic beverage in public;

26 e. **No Guns or Dangerous Weapons:** Anywhere in public view or anyplace
27 accessible to the public, (1) possessing any weapons: firearms, including BB guns, pellet guns
28 and replica guns, ammunition, knives, baseball bats without a legitimate purpose, or illegal
29 weapon as defined in Penal Code section 12020, (2) knowingly remaining in the presence of

1 anyone who is in possession of such gun, ammunition or dangerous weapon, or (3) knowingly
2 remaining in the presence of such gun, ammunition or dangerous weapon;

3 f. **No Fighting:** Engaging in fighting in public streets, alleys and/or public and
4 private property;

5 g. **No Trespassing:** Being present on any property not open to the general public,
6 except with (1) the prior written consent of the owner, owner's agent, or the person in lawful
7 possession of the property, or (2) in the presence of and with the voluntary consent of the owner,
8 the owner's agent, or the person in lawful possession of the property;

9 h. **No Blocking Free Passage:** Blocking the free passage of any person or vehicle
10 on any street, walkway, sidewalk, driveway, alleyway, or other area of public passage;

11 i. **No Graffiti/Vandalism or Tools:** (1) Spray painting, marking with marker pens,
12 or otherwise applying graffiti on any public or private property, or (2) possessing spray paint
13 cans, marker pens or other objects capable of defacing property;

14 j. **No Acting as Lookouts:** Acting as a lookout, whistling, yelling or otherwise
15 signaling another person to warn of the approach or presence of law enforcement officers;

16 k. **No Gang Hand Signs:** Using words, phrases, physical gestures, or symbols
17 commonly known as hand signs, which describe or refer to the gangs known as OLD TOWN
18 NATIONAL CITY, also known as OTNC, such as: spreading fingers apart, with thumb tucked
19 down, and crossing the two middle fingers to form the letter "W" (for Westside); placing their
20 thumb and forefinger together and extending the other fingers downward to form a "P" (for
21 Pueblo Viejo); extending their index and middle finger of each hand to create a "V" (for Varrio
22 Viejo);

23 l. **No Gang Clothes:** Wearing clothing or accessories, including, but not limited to,
24 blue bandanas, necklaces, earrings, hats, or belt buckles, which bear the name, initials, letters, or
25 numbers, including Roman numerals, of the gang known as OLD TOWN NATIONAL CITY,
26 also known as OTNC, as follows: "O"; "T"; "N"; "C"; "OTNC"; "1520"; "15" "20"; "NC";
27 "West Side"; "P" "V"; "Pueblo Viejo"; "V" "V"; "Varrio Viejo"; "OBS"; "IBS"; "XV-XX";
28 "15-XX"; "Old Town" or the number "13"; or any clothing or accessories which display their
29 gang moniker;


1 m. **No Burglary Tools:** Possessing burglary tools with no legitimate purpose,
2 including, but not limited to screwdrivers, shaved keys, spark plugs or porcelain casings, or
3 other devices capable of being used to break into locked vehicles;

4 n. **No Littering:** Littering in any public place or place open to public view;

5 o. **Juvenile Curfew:** If under the age of eighteen (18), being in a public place
6 between the hours of 10:00 p.m. on any day, and 6:00 a.m. of the following day, unless (1)
7 accompanied by a parent or legal guardian, or by a spouse eighteen (18) years of age or older, or
8 (2) performing an errand directed by a parent or legal guardian, or by a spouse eighteen (18)
9 years of age or older, or (3) returning directly home from a public entertainment, such as a
10 movie, play, sporting event, dance or school activity, or (4) actively engaged in some business,
11 trade, profession, or occupation which requires such presence;
