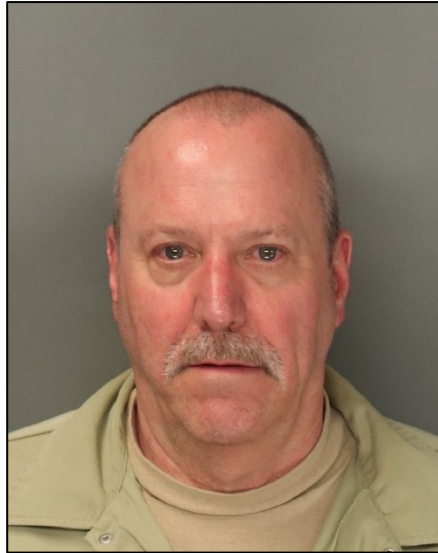

## Sex Offender Community Notification

On May 27, 2020, the SAFE Task Force went door to door in the Jacumba Hot Springs and Boulevard areas to inform the community about a Sexually Violent Predator (SVP) who will be living in their neighborhood. The San Diego Superior Court granted Michael Poulson his conditional release and he is scheduled to move to 45612 Old Highway 80 in Jacumba Hot Springs on or before June 5, 2020. Michael Poulson is registered as a "Sexual Violent Predator" sex offender with the California Department of Justice and the County of San Diego. This classification is based on felony convictions for lewd and lascivious acts against female children under (14) years of age between 1985 and 1995. Poulson served several years in state prison for his crimes. Poulson is scheduled to be released from Coalinga State Hospital any time prior to June 5, 2020 and has a lifetime requirement to register as a sex offender.

Poulson is not wanted by the Sheriff's Department at this time. California Penal Code Section 290, also known as "Megan's Law," permits law enforcement agencies to warn the community about sex offenders who frequent the area. The purpose of this notice is to allow members of the public to protect themselves and/or their children from sex offenders.

This notification is not intended to induce fear; rather it is our belief that an informed community is a safer community. Use of this information to threaten, intimidate, or harass the subject or any other person will not be tolerated and may result in prosecution.

**The Sheriff's Department, The District Attorney's Office and The SAFE Task Force are not responsible for the selection of this location. The selection process was the responsibility of the Department of State Hospitals and the San Diego Superior Court.**
