Domestic Violence and Sexual Assault Victim Services

- <u>California Indian Legal Services</u> Domestic violence legal services continue to be offered remotely. There is no in-person contact with clients at this time. Contact (760) 746-8941.
- <u>Center for Community Solutions</u> All CCS services are still available, most of which are offered remotely. Both shelter locations (Hidden Valley House-North Inland and Project Safehouse East County) are still operating and accepting clients.  - Adult and child individualized therapy and child advocacy available remotely, but there is currently a waitlist.
 - Sexual assault advocacy available for system navigation, discussion of options moving forward, and accompaniment for exams.
