Regardless of whether you choose to pursue the legal advice funded through the Renovate America Final Judgment, we recommend you **immediately** take whatever private action you deem appropriate to protect and enforce your rights. Depending on when you entered your contract, you may have legal deadlines that require you to take legal action within a certain time period.
