IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Permanent Gang Injunction shall be and hereby is granted and that plaintiff recover no monetary sum from the defendants.

PERMANENT GANG INJUNCTION

After due consideration of all papers filed in this action, including the moving papers and evidence submitted in support of plaintiff's Ex Parte Application For Order To Show Cause Re: Preliminary Injunction, the deemed admissions of the defaulting defendants and the authorities presented by counsel, this Court makes the following finding of facts by clear and convincing evidence:

3	Lado de Loma Drive and Vista Village Drive. This portion of SAFETY ZONE 1 is bordered
4	on the north by Vista Village Drive and connects northeast to the San Diego Northern
5	Railway railroad tracks, which are owned by the North County Transit District, connecting
6	north to North Drive, connecting southeast to W. East Drive, connecting east to Woodrail
7	Drive, connecting north to 448 Dorsey Way, connecting east and north on Dorsey Way to W.
8	Bobier Drive, which borders the Bobier Elementary School to the north, connecting east to
9	Goodwin Drive, which borders the Vista High School to the west, and connecting north to
10	Gail Drive, which borders Vista High School to the north, connecting east and then south on
11	Gail Drive to 565 E. Bobier Drive, connecting west to Heidi Circle, which borders the Sierra
12	Vista High School to the east, and south to the cul-de-sac of Acateno Avenue, connecting
13	west to Cananea Street and connecting south to E. Indian Rock Road, connecting southeast
14	to Townsite Drive and connecting east to E. Vista Way, connecting southwest on E. Vista
15	Way to Escondido Avenue, which borders the Lincoln Middle School to the east, and south
16	to Eucalyptus Avenue, which borders the Lincoln Middle School to the south, connecting
17	west to Park Avenue and connecting west to S. Santa Fe Avenue, connecting south on S.
18	Santa Fe Avenue to Guajome Street, connecting west to Lado De Loma Drive and
19	connecting west to Vista Village Drive, and extending 100 yards to the outside of any
20	boundary street. SAFETY ZONE 2 starts at the intersection of S. Santa Fe Avenue and Pala
21	Vista Drive and is bordered on the west by Pala Vista Drive, connecting south to the San
22	Diego Northern Railway railroad tracks, connecting east to 1115 S. Santa Fe Avenue and
23	connecting west, back to Pala Vista Drive, and extending 100 yards to the outside of any
24	boundary street. SAFETY ZONE 3 encompasses Brengle Terrace Park, which is bordered
25	on the south by Vale Terrace Drive, and extending 100 yards to the outside of any boundary
26	street. The VHB SAFETY ZONES include both sides of the streets listed above, as well as

any alleys, driveways, parking lots, businesses and structures located thereon. (See Exhibit A, lodged herewith)

- a. No Association With Known Gang Member: Standing, sitting, walking, driving, gathering or appearing, anywhere in public view or any place accessible to the public, with any named Defendant herein or any known member of the VISTA HOME BOYS, also known as VHB criminal street gang;
- b. **No Intimidation:** Confronting, intimidating, annoying, harassing, threatening, challenging, provoking, assaulting, or battering any person known to be a witness to or victim of crime, or any person known to have complained about the gang activities of the VISTA HOME BOYS also known as VHB criminal street gang;
- c. Stay Away From Drugs In Public: (1) Participating in the selling, possessing or using of any controlled substance, or illegal drug, including, but not limited to: phencyclidine (PCP), heroin, cocaine, cocaine base, methamphetamine, ecstasy and marijuana; (2) possession of related drug paraphernalia, including, but not limited to, rolling papers, pipes, or other devices used for injecting, smoking or ingesting illegal drugs; (3) knowingly remaining in the presence or anyone selling, possessing, or using any controlled substance or illegal drug; or (4) being under the influence of a controlled substance, or illegal drug;
- d. Stay Away From Alcohol In Public: Anywhere in public view or anyplace accessible to the public, (1) drinking or possessing an open container of an alcoholic beverage, (2) being under the influence of alcohol; (3) knowingly remaining in the presence of anyone possessing an open container of an alcoholic beverage in public; (4) knowingly remaining in the presence of an open container of an alcoholic beverage in public;
- e. No Guns or Dangerous Weapons: Anywhere in public view or anyplace accessible to the public, (1) possessing any weapons: firearms, including BB guns, pellet guns and replica guns, ammunition, knives, baseball bats without a legitimate purpose, or illegal weapon as defined in Penal Code section 12020, (2) knowingly remaining in the

presence of anyone who is in possession of such gun, ammunition or dangerous weapon, or (3) knowingly remaining in the presence of such gun, ammunition or dangerous weapon;

- f. **No Fighting:** Engaging in fighting in public streets, alleys and/or public and private property;
- g. **No Trespassing:** Being present on any property not open to the general public, except with (1) the prior written consent of the owner, owner's agent, or the person in lawful possession of the property, or (2) in the presence of and with the voluntary consent of the owner, the owner's agent, or the person in lawful possession of the property;
- h. **No Blocking Free Passage:** Blocking the free passage of any person or vehicle on any street, walkway, sidewalk, driveway, alleyway, or other area of public passage;
- i. No Graffiti/Vandalism or Tools: (1) Spray painting, marking with marker pens, or otherwise applying graffiti on any public or private property, or (2) possessing spray paint cans, marker pens or other objects capable of defacing property;
- j. No Acting as Lookouts: Acting as a lookout, whistling, yelling or otherwise signaling another person to warn of the approach or presence of law enforcement officers;
- k. No Gang Hand Signs: Using words, phrases, physical gestures, or symbols commonly known as hand signs, which describe or refer to the gangs known as VISTA HOME BOYS, also known as VHB, such as: extending the index finger and middle finger straight up, and spreading them apart to form a "V"; or place both elbows together, and spreading the forearms apart to form a "V"; using a forearm extended straight up in front of the body, or both forearms together, in front of the body to form an "I"; placing one hand on top of the other, with the fingers curved to form a half-circle to form the letter "S"; placing one forearm on top and perpendicular to the other forearm to form the letter "T"; and placing one hand on the other arm and extending that elbow away from the body to form the letter "A";

1	1. No Gang Clothes: Wearing clothing or accessories, including, but not limited
2	to, blue bandanas, necklaces, earrings or belt buckles, which bear the name, initials, letters,
3	or numbers, including Roman numerals, of the gang known as VISTA HOME BOYS, also
4	known as VHB, as follows: "VISTA"; "V"; "VHB"; "22"; "22" "8" "2"; "South"; "Sureno"
5	"Sur"; and the number "13;" or any clothing or accessories which display their gang
6	moniker;
7	m. No Burglary Tools: Possessing burglary tools with no legitimate purpose,
8	including, but not limited to screwdrivers, shaved keys, spark plugs or porcelain casings, or
9	other devices capable of being used to break into locked vehicles;
10	n. No Littering: Littering in any public place or place open to public view;
11	o. Juvenile Curfew: If under the age of eighteen (18), being in a public place
12	between the hours of 10:00 p.m. on any day, and 6:00 a.m. of the following day, unless (1)
13	accompanied by a parent or legal guardian, or by a spouse eighteen (18) years of age or
14	older, or (2) performing an errand directed by a parent or legal guardian, or by a spouse
